

William Augustus Bowles




The BILLY BOWLEGS' FESTIVAL has William Augustus Bowles, a notorious old boy, as its patron pirate. Bowles, a former naval officer married to the daughter of a Creek Indian Chief, arrived in what was to become Florida's "Playground Area" in 1778 when the Spanish, English and Americans were maneuvering for control of the Gulf shores and its shipping lanes. He quickly took advantage of the many disputed claims of ownership by these countries, setting himself up as the "King of the State of Muscogee",

laying claim to most of what is now Florida, Georgia and Alabama.... Cap'n Bowlegs gathered up a force of Indians, army deserters and general riffraff - a rolicking, piratical crew which, playing no favorites when it came to picking their victims, grew to be a concern to all three of the power-hungry countries. Bowles created his own throne and the three nations considered everything from murder to a general's commission to get him on the right side! financed by loot from a Spanish ship and surrounded by a handful of Indians, Cap'n Billy invaded English society for support. He was awarded, so go the legends, with a flag of "English and Indian colors mixed", a silver pipe, a tomahawk, a chain of friendship and trade supplies for his new State of Muskogee. After being enticed by the Spanish to New Orleans and captured, he was shipped out to Madrid and later to the Philippines where he jumped ship and returned to his "state" and greater deeds of piracy ... When the Spanish regained Florida in 1783, they granted exclusive trading rights to the English firm of Panton, Leslie & Co. and, although allied with Alexander McGillivray, powerful Chief of the Creeks, it's monopoly was often challenged by rival Indians. 1788, Bowles hoping to subplant McGillivray as leader of the Creek Nation, led a series of disruptive raids ending in an unsuccessful attack on the trading post of St Marks in 1792.... he was then captured by the Spanish and imprisoned in Havana. The Spanish took poor ol' Cap'n Bowlegs to Morro Castle there, in 1803, he starved himself to death rather than to "sink so low as to speak to the Cuban general"!





Treasures of the Upper Gulf Coast



Pensacola's Fort San Carlos, an old Spanish bastion built in the 17th century, could tell many tales. One of these involves the notorious pirate, Billy Bowlegs, and a secret cavern that still lies hidden somewhere beneath the Fort. Two carefully concealed tunnels served as entrances to a larger hidden chamber; one leading from within the Fort itself, and the other from a well-hidden spot somewhere outside the fort's thick stone walls.

These tunnels, and their accompanying cavern, served two official purposes. First, they served as entrances and exits for Spanish spies reporting their typically clandestine activities to the Fort's Commandant. Also they were valuable as escape tunnels in case of a siege, either by a foreign power or by the inevitable hostile Indians, in the event that the Fort was overrun.

It is not known why or how Billy Bowlegs discoverd and decided to use this hidden cavern, sometime in the early 1800's. What is known is that he did turn it into a vault for some \$3,000,000 in pirate gold, and an old map once seen by the authors authenticates the existence not only of the treasure, but also the approximate location of the fort's well-hidden tunnel. What a find for some lucky person able to untangle the Fort's mysteries!

Moving further south along the "Highway of the Seas", as we could well call the waters off Florida's West Coast (ships stuck fairly close to land during the three centuries preceding our own), we reach another site attributed to Billy Bowlegs. Many coins and silver bars reputedly buried by Billy have been recovered in scattered locations along the beach, but many more finds still exist. The coins, lucky hunters report, are contained in the remains of small leather pouches buried six to twelve inches below the surface of the sand and shell. In fact, beach erosion in recent years has laid bare some of these bars out in the water itself - lucky finds for swimmers or skin divers."

History of the Festival

The BILLY BOWLEGS' FESTIVAL grew out of a Labor Day ski show celebration back in 1953, which was the brainchild of some enterprizing young busi-

nessmen, the JAYCEES, eager to latch onto a project that would warrant their time and efforts, be fun and bring more tourists into the area. The idea of a Gasparilla-type observance centered on a "pirate" theme and they unanimously chose as their patron pirate the notorious and legendary WILLIAM AUGUSTUS BOWLES, a pirate of controversial authenticity whose alleged, dastardly deeds were widespread throughout what is now known as "The Playground Area". NATHAN FLEET, a downtown Fort Walton Beach retail merchant at that time, was chosen as the first Cap'n Billy Bowlegs to reign over the Festival and lead the pirate "raids" (In later years, his son, JUDGE ERWIN FLEET, reigned as Bowlegs XIV).

The overwhelming success and acceptance of the initial celebration sparked great enthusiasm and interest among other businessmen of the community. A small group of merchants, of which two, together with two from the JAYCEES, were secretly delegated to choose from the member list the Billy Bowlegs as reigning pirate of the threeday fiesta, his identity to remain unknown until the unmasking ceremonies took place on the evening of the grand ball ... due to the huge success of the festival, events were added such as, treasure hunts for children, parades, gigantic fireworks displays, athletic events, a landing to include the townspeople with the "capture" of the City and the hoisting of the Jolly Rodger to signify the total surrender of the City. Beards were grown, costumes made and over the years became more elaborate. Professional floats were added to the Grand Torchlight Parade and a glittering Coronation Pageant, open to the public, at which a new Cap'n Billy, his queen, a First Mate and his lady, ten honor guard couples and children of the court are unmasked each year, with a private ball and midnight breakfast for Krewe members and honored guests climaxing the now week-long Thus, a tradition was born: THE BILLY BOWLEGS' FESTIVAL, with the infamous KREWE OF BOWLEGS and its current Cap'n as the "STAR" of the show!

ROGER CLARY was the first Cap'n Billy under organized charter, starting with a small membership to its present 165, plus former Cap'n Bowlegs who automatically become members of "The Society of Bowlegs". Membership is limited by By-Laws and there is always a waiting list.

Hours of volunteered time and sizeable sums of money (all Krewe events are paid for from Krewe annual membership dues) are expended each year on colorful floats, impressive decorations and gaily colored costumes worn by the Krewe during the parade, pageant and ball. The beautiful floats which the masked Krewe ride, allow the members to throw showers of souvenir trinkets and coins to the thousands lining the parade route. Each year, Cap'n Billy is selected by secret ballot; he, in turn, choses his queen, first mate and court.

... All past-queens belong to an organization known as "The Society of Queens". Among other things, they sponsor an annual punch party for graduating senior girls, daughters and/or granddaughters of Krewe members. These girls are "presented at court" during the Coronation Pageant each year. In colorful costumes, they also assist the pirates during their annual raid on the City.



Up until 1970, the coronation ceremonies had been on a small, informal scale. JIM KENDRICK, Cap'n Billy Bowlegs XVI and a member of that early group of JAYCEES who had the dreams, vision and enthusiasm needed to keep that "spark" going each year, also conceived the present elaborate Coronation Pageant as we now know it, inviting the general public to share with the Krewe a wonderful evening's entertainment, always with a few surprises in store for all!

Tonight, as we help celebrate the Krewe's 28th Coronation Pageant, please come with us once more to Fantasy Island where Cap'n Billy Bowlegs XXVII, his queen and court are granted one last fantasy before turning over Krewe business to a new regime ... to go back in time when the first warriors lived and played on the snow white sand dunes formed by winds from the emerald green waters of the Gulf of Mexico ... "Once Upon a Time", as all good stories should start, maybe even 12,000 years ago, the Playground area welcomed its first tourists when the Indians came here to fish and perhaps even play games and chase lovely Indian maidens up and down the dunes! History tells us that about 4000 B.C., a permanent settlement was established where downtown Fort Walton Beach is today centered on a mound built with a half-million baskets of dirt and surmounted by a ceremonial "temple", the area was the center of Indian religion, government and culture. Now designed a National Historic Landmark, the Mound has been completely restored with the construction of a temple at its summit and the Indian Temple Mound Museum beside it to house artifacts of the several Indian cultures associated with the area. This, too, all started with a dream -Begun as a hobby by the late William Lazarus, his wife, Yulee, completed his work and saw his dream come true on the completion of the beautiful Indian Temple Mound Museum which now houses the largest collection in existence of pottery from the Fort Walton culture, a fascinating example of early Indian art used in rituals lost with the centuries.

... for the next hour, come join with us in a trip back through time for a "Happening with the First Americans". Our journey starts with scenes from early Camp Walton, its children and early, colorful citizens that used to gather at Buck's Store to swap tales and whatever else "they had a mind to". Who knows, maybe one of their favorite tall tales was when ol' Cap'n Billy Bowlegs and his band of cut-throat pirates raided and plundered and buried their gold!
