HISTORY of the »»

he BILLY BOWLEGS FESTIVAL, now in its 37th year, got its start as a water ski show on Labor Day sponsored by the City of Fort Walton Beach Recreation Department. It was a crowd pleaser! ... but the City decided it was too large for them to handle so they asked the Jaycees, then in their first year as an organization to The Jaycees, after a lot of research and planning take it over. meetings, agreed to sponsor the event. The events that year consisted of a parade, a fish fry, ski show and dance at the Community Center. (Incidentally, the Jaycee membership at that time was only 17!) The idea of a Gasparilla-type celebration centered on a pirate theme. All were unanimous in their choice of the notorious and legendary WILLIAM AUGUSTUS BOWLES as their patron pirate ... a pirate of controversial authenticity whose alleged, dastardly deeds were widespread throughout what is now known as the PLAYGROUND AREA or the EMERALD COAST.

After the overwhelming success of this initial celebration, a small group of merchants, together with the Jaycees, were secretly delegated to choose from its membership a Cap'n Billy Bowlegs as reigning pirate of the then three-day festival. His identity would remain a mystery until the unmasking ceremonies took place on the evening of the grand ball. The late NATHAN FLEET, a downtown retail merchant, was chosen as the first Cap'n Billy Bowlegs to reign over the festival and lead the pirate raids. He played his role so well, he was asked again the following year to lead the pirate crew. (His son, Judge Erwin Fleet, was Cap'n Billy Bowlegs XIV in 1968-69).

During the festival, races are run, tournaments played, arts and crafts displayed, boats paraded, bands play, the small fry fish, square dancers kick up their heels, marathons are held, skirmishes are fought, and the gaily costumed pirates land again on the beautiful white sand beaches of Northwest Florida -- the MIRACLE STRIP! The City is duly captured and the "Jolly Roger" is hoisted to signify the total surrender of the City. There is fun for the entire family with treasure hunts for the children as well as for grownup children ... and a treasure map to help with the search! years, more and more professional floats have been added to the Grand Torchlight Parade and a glittering Coronation Pageant (open to the public at no charge) is held. During the pageant, a new Cap'n Billy Bowlegs, his Queen, a First Mate and Mistress, ten Honor Guard couples and children of the court are unmasked and introduced. The Coronation Pageant is followed by a private ball and midnight supper for Krewe members and their honored guests.

Thus a tradition was born: the BILLY BOWLEGS FESTIVAL with the infamous KREWE OF BOWLEGS and reigning Cap'n Billy as the "stars" of the show!

 $m{A}$ n early souvenir program and guide(1957) lists 75 Krewe members: five of these are still members, as well as a second generation of pirates. Several sons of original Krewe members are now carrying on a tradition started by their fathers. CLARY, Cap'n Billy Bowlegs II, was the first Cap'n Billy Bowlegs under organized charter. Current Krewe membership is 170, plus former Cap'n Billys who automatically become members of the SOCI-ETY OF BOWLEGS, otherwise affectionately known as the S.O.B.'s! Membership in the Krewe is limited by the Constitution & Bylaws of the Krewe and there is always a waiting list. Hours of volunteered time and talent, plus sizeable sums of money are expended each year by Krewe members and their wives on colorful floats, beautiful decorations and custom-made costumes worn by the Krewe during the parade, pageant and ball. The floats which the masked Krewe ride, allow the members to throw showers of souvenir trinkets and "gold" doubloons to the thousands lining the parade ALL KREWE EVENTS ARE PAID FOR FROM KREWE ANNUAL MEMBER-SHIP DUES - they receive NO FUNDING FROM ANY OTHER SOURCE! Each year Cap'n Billy is selected from Krewe membership by secret ballot; he, in turn, chooses his Queen, First Mate & Mistress, ten-man Honor Guard and the children of the court ... their identity a closely guarded secret until coronation night.

The late Docie Bass, Cap'n Billy Bowlegs IV, was the first to choose his Queen from the membership of the Krewe. Up until that time, queens had been "captive wenches" and beauty contest winners. Past queens belong to the SOCIETY OF QUEENS ... among other things they sponsor an annual tea for graduating senior girls (daughters and/or granddaughters of Krewe members.) These girls are presented at Cap'n Billy's court during the Coronation Pageant and serve as the court's princesses. In colorful costumes, they also assist the pirates during their annual raid and skirmish. The princesses and their escorts are invited to attend the Coronation Ball, as well as graduating senior boys of Krewe members and their dates.

WILLIAM HERBERT TINSLEY, Captain Billy Bowlegs XXXVI, a native of Bowling Green, Missouri, received bachelor's and master's degrees in finance and banking from the University of Missouri. He was commissioned a second lieutenant in the U,S. Air Force in 1967 and served four years as a supply operations of ficer at Hurlburt Field, where he was named Junior Officer of the Year in 1969.

Cap'n Billy, a member of the Krewe since 1972, served on the Honor Guard in 1977-78 and was First Mate in 1984-85. He has also been a board member, serving as treasurer in 1989-90.

His wife, the former Dolly Rentz of Andalusia, Alabama, is a graduate of Choctawhatchee High School, Okaloosa-Walton Community College and the University of West Florida. She is active in school volunteer activities.

The Tinsleys and their sons, Kent, 17 and Kirk, 10, attend the Mary Esther United Methodist Church. Kirk has served as Cap'n Billy's sword bearer this past year. The family resides in Fort Walton Beach.

Queen CARLEE FOSTER was born in Long Island, N.Y., but has lived most of her life in the South. She holds a bachelor's degree in education from the University of Alabama and is a former second-grade and special education teacher.

Her civic and social clubs include Junior League, Shalimar Pointe Ladies Tennis Team and Mardi Gras Club.

Carlee's husband, William Scott ("Scotty") Foster, is a partner in the law firm of Anchors, Foster and McInnis. They have lived in this area since 1983, and are members of St. Simon's Episcopal Church where she is a former Sunday school teacher.

The Fosters have two sons. Scott attends Santa Fe Community College in Gainesville and Gresham is an eighth-grader at Bruner Middle School.

Queen Carlee's gown is of black silk satin with arabesques of silver repeated on the skirt and bodice. A duplicate of her crown is placed in the front center of the gown. Her petal-shaped collar is encrusted with crystals, gold and white pearls and her scalloped black velvet train is bordered by loops of crystal braid set with large colored stones. A monogram is framed by a pair of red lamé crawfish, and in keeping with this year's theme, a street scene featuring a Bourbon Street trolley car is placed in the center of the train. Also on the train is a red lamé "A" and a silver brocade Crimson Tide elephant. A fleur de lis at the top of the train is fashioned of rhinestones, pearls and gold lamé.

notorious old boy, so the legend goes, and patron pirate of the BILLY BOWLEGS FESTIVAL and the KREWE OF BOWLEGS, was born in When he was only 13, he joined the 1763 on the Maryland frontier. Loyalists Corps to fight against the American rebels. Two years later he was sent to Pensacola to join the British forces operating At the age of 16 he was commissioned an ensign in the British Navy ... after the war, he rebelled against military life and went into hiding with the Creek Indians after insulting a British officer (again, so the legend goes!). He married a tribeswoman, a chief's daugher, and in 1781 was welcomed back by the British to help battle the Spanish at Pensacola... at that time, the British, Spanish and Americans were maneuvering for control of the Gulf shores and its shipping lanes. Believing himself destined to command instead of obeying orders, Bowles gathered a force of a "couple hundred plundering Indians, relics from the American Army and white banditti" ... a rolicking piratical crew which grew to be the concern of all three of the power-hungry countries. He created his own throne and the three nations considered everything from murder to a general's commission to get him on the right side. Financed by loot from a Spanish ship and surrounded by a handful of Indians, Cap'n Billy invaded British society for support. He was rewarded with a flag of "English and Indian colors mixed", a silver pipe, a tomahawk, a chain of friendship and trade supplies with which he formed the State of Muskogee. He was eventually captured by the Spanish and shipped to Madrid, Spain, and then to the Philippines, but he jumped ship and returned to his "state" and greater deeds of piracy...but all "good" pirates must have an end; and Cap'n Billy's came after he was lured to peace talks and there betrayed by his Indian troops. The Spanish imprisoned him in Cuba in the infamous Morro Castle - there, on December 23, 1805, he died. There are many reports as to how he died but whatever happened to Billy Bowlegs was not worth remembering to the people of that period, for he has no grave. To the Ft Walton Beach/Destin area, however, he left a heritage of pirate tales of great adventure and buried treasure!


